

d.	Revenue Sharing (From 3 rd year)	No revenue shall be shared for the first two years. From 3 rd year 2% of Annual Gross Revenue (AGR) shall be shared.

f.	Late fee	The annual license fee and the amount of revenue to be shared has to be paid within due time. The amount due may

		be paid till 60 (sixty) days after the due date by paying late fee at the rate of 15% (fifteen percent) per annum as compensation to the Commission.
13.	Charge of Share transfer/network equipment sale of all types of license:	5.5% of the Selling price of the shares/ infrastructure/ network equipment.
14.	Merger Fee:	1% of the total share value of merged Company.
15.	Fees and Charges payable against all licenses approved by the Commission shall exclude 15% VAT. Each licensed operator shall, as per the এস.আর.ও নং-১৭৯-আইন/২০১২/৬৩৭-মসক of NBR প্রজ্ঞাপন তারিখ ০৭-০৬-২০১২, pay the Commission 15% VAT on license fees, charges etc., during payment of the concerned fees, charges etc.	

The above rates shall remain inforce until revised/modified by Bangladesh Telecommunication Regulatory Commission.
